

#### Client Charter

Elysium Group Pty Ltd regards people as intrinsically valuable and respect their rights, including the right to autonomy and justice. Elysium Group Pty Ltd engages in conduct which promotes equity and the protection of people's human, legal, and moral rights. They respect the dignity of all people and peoples.

As a client of Elysium Group Pty Ltd, you have rights that are important for you to understand to ensure the best management of your mental health needs.

## Privacy and Confidentiality

This client charter is designed to inform you about the management of information that you disclose to your psychologist. Psychological treatment is a highly personal experience and it is important for the success of treatment that you have confidence in the responsible gathering and retention of your personal information and records.

As part of providing a psychological service to you, Elysium Group Pty Ltd will need **to** collect and record personal information that is relevant to your current situation. Collection of personal information is necessary to ensure the most effective and accurate psychological assessment and therapy.

Information is gathered as part of the assessment, diagnosis and treatment of an individual and is managed by your treating psychologist. The information is retained in order to document what happens during sessions, and enables the psychologist to provide a relevant and informed psychological service.

You psychologist may disclose confidential information obtained in the course of treatment only under any one or more of the following circumstances:

- a) with you consent or a person with legal authority to act on your behalf;
- b) where there is a legal obligation to do so;
- c) if there is an immediate and specified risk of harm to an identifiable person or persons that can be averted only by disclosing information; or
- d) when consulting colleagues, or in the course of supervision or professional training, provided the psychologist:
  - conceals the identity of clients and associated parties involved; or
  - obtains the client's consent, and gives prior notice to the recipients of the information
    that they are required to preserve the client's privacy, and obtains an undertaking from
    the recipients of the information that they will preserve the client's privacy

There may be times where, as part of the assessment and therapy process, it may be helpful for your psychologist to liaise with other people or agencies that are relevant to your therapy goals (i.e. supervisor, GP, specialist, parent, educational institution, WorkCover, etc).



Please note that if you intend to claim rebates from Medicare or another organisation (such as WorkCover or TAC) then your psychologist must provide summary reports to external agencies regarding your treatment progress. Under the Medicare scheme these reports will normally be sent to your GP or psychiatrist.

### Accessing your Client Information

A client has the right to access information in their file, unless one of the exceptions applies.

- giving access would pose a serious threat to the physical or mental health of any individual
- giving access would jeopardise the privacy of others
- giving access would hinder any law enforcement activities

If you wish to view and / or have a copy of the material recorded in your file then, by law, it is necessary to make the request in writing and send it to:

All employees or representatives of Elysium Group Pty Ltd exercise their power appropriately and honour this position of trust, keep faith with the nature and intentions of their professional relationships and act with probity and honesty in their conduct.

If you need to cancel or postpone the appointment, please give your psychologist at least 24 hours' notice

Please note it is often very difficult for a psychologist to book a new client at very short notice. Therefore cancellations or now shows restrict the access for other clients. Elysium Group Pty Ltd incurs room rental fees due to the allocation of time for your appointment. So we hope you understand and appreciate why we must charge a cancellation fee for cancelled/ missed appointments.
